## KMY215 - HISTORY OF POLITICAL THOUGHTS I - Fen Edebiyat Fakültesi - Felsefe Bölümü General Info

Objectives of the Course

The History of Political Thought course will examine the intellectual development of humanity starting from the first civilizations to the present day and will open the political dimensions of this development to discussion. In this way, students will be introduced to the foundations of political thought and the dimensions of its development. This perspective will also form the basis for students' capacity to understand and evaluate social theory.

Course Contents

The History of Political Thought course has a content that examines the political dimensions of the intellectual development of humanity from past to present. The ways of living and thinking of primitive societies, which are the roots of today's thought, constitute the first subject to be emphasized. Thus, the traces of the transition from primitive society to civilized society reflected in political thought will be traced. For this purpose, the forms of governance tried in the Greek Site State and the political thinkers (Socrates, Plato, Aristotle, etc.) and ideas that were the source of them constitute an important topic to be emphasized. In fact, Polis, which is the source of the word Politics, symbolizes the city-state, which is considered the cradle of classical Greek civilization. When we look at the form of government of this structure, we see first the kingdom, then the Aristocracy (minority) rule and then democracy. From the 5th century B.C. onwards, the Greek site states faced the phenomenon of losing their independence against the Macedonian king. This period of Macedonian rule is referred to as the Hellenistic period, separating it from the classical era of Greece. Again, the philosophical schools that developed in this period, when Greek culture spread to the east of the ancient world, will be elaborated in detail on their reactive approaches to the collapse of the site states. After examining the ancient period, we will move on to the intellectual movements created by the Middle Ages. The general characteristic of this period is that it put reason under the command of faith with the immutability in the way of thinking it put forward. The main characteristic of medieval thought is that all problems are based on religion and solutions are sought according to the principles of religion. These problems included concepts such as God, the soul, the universe, creation, immortality. The environment of this period will be discussed separately for the Christian and Islamic worlds. From the late 15th century onwards, feudal relations began to dissolve completely and rapidly in the field of economy, and new non-agricultural sources of wealth accelerated social and political transformations. With new and radical changes that opposed the medieval structure in every field, a centralized administrative process, which can be called the Period of Monarchies, was experienced until the 18th century. In this process, it is understood that liberal democratic values developed and then the transition to parliamentary democracy accelerated, and that the declarations of rights and freedoms of the Western world were the source of all this process. In this course, new political values will be discussed in broad terms in interaction with social, economic and cultural transformations, based on this general outline of the history of civilization.
