

Objectives of the Course

To analyse a book written in the field of archaeology and/or social anthropology during the term

Course Contents

The books selected by the lecturer will be chosen by each student according to his/her field of interest. The book will be summarised every week according to its chapters, if any, or according to certain page ranges if not divided into chapters, and the student will be expected to both write a written text and transfer it orally.

Recommended or Required Reading

Archaeology and/or social anthropology books that are easily accessible to the student and that the lecturer will provide and give to the student when necessary. Planned Learning Activities and Teaching Methods

The student is expected to prepare a 1 (one) page summary of the book he/she is responsible for, by reading the page range determined for the relevant week, with his/her own original sentences, paying attention to the spelling rules. The student is required to create a dictionary from the words such as terms, concepts, geographical units that he/she does not know in the chapter he/she reads and to indicate the imprint of the sources he/she uses while doing the dictionary work. He/she is also expected to submit this written assignment orally during the class time. This process is repeated every week. 6 (six) weekly summaries, in the form of a 3 (three) page composition, in their own original sentences, paying attention to the rules of spelling, are accepted as midterm homework. At the end of the semester, a 5 (five) page essay in the form of a composition, using the weekly summaries, with their own original sentences, paying attention to the rules of spelling, dictionary work and 1 (one) paragraph in which they express their personal opinions and what the book has contributed to them are accepted as final homework.

The student may receive counselling from a faculty member outside of class hours.
