FIRST PART

Purpose, Scope, Basis and Definitions

Goal

Article 1 - The purpose of this Regulation is; higher education institutions registered students training in Turkey, health, fitness and meeting the cultural needs and respecting the rights for the development, ensure that they are sensitive to national interests, institutions of higher education management bodies with students in effective communication by establishing students' expectations and convey the wishes of the governing bodies and students

The aim of this course is to organize the Student Councils of Higher Education Institutions to be established in order to ensure their participation in the decisions on education and education, and to establish the establishment, duties, powers and working principles of the Higher Education Institutions National Student Council to represent them at national and international level.

Scope

Article 2 - This Regulation shall; undergraduate in the University Institute of Technology in Turkey, license and the provisions on the establishment, duties, authority and working principles of the Council of Higher Education Institutions Student Councils and Higher Education Institutions National Student Council to be established with the authority to represent graduate students.

Base

Article 3 - This Regulation has been prepared on the basis of Articles 7 and 65 of Higher Education Law No. 2547.

Definitions

Article 4 - In this Regulation;

- a) Higher Education Council Student Council: The student council which the students establish in the institutions of higher education among themselves in a democratic way,
- b) Department / Programme / Undergraduate Degree / Student Dean Representative: A higher education institution; each department / program / department of the faculty, school, conservatory, vocational college or institute of the department or program /

pupils elected to represent the pupils of the main school in the Student Council,

- c) Department / Program / Undergraduate Degree / Elementary School Student Representative Council: A higher education institution; The board consisting of the representatives of the department / program / department or the department of the faculty, school, conservatory, vocational college or institute,

d) Faculty / High School / Conservatory / Vocational School / Institute Student Representative: A higher education institution; faculty, higher education, conservatory, vocational college or institute, department / program / department of education, or student representatives of the department, faculty / college / conservatory / vocational school or institute students to represent the students in the Student Council,

e) Student Council General Assembly: A board consisting of representatives of faculties, higher schools, conservatories, vocational schools and institutes in a higher education institution,

f) Student Council Convention: The general assembly meeting of the Student Council which is held in November every year with the participation of faculty, higher education, conservatory, vocational school and institute student representatives of a higher education institution,

g) Council of Student Conventions Council of Councilors: In the Council of Student Conventions, the agenda items shall be in compliance with the provisions of this Regulation and the directives of the higher education institutions.

The Board of the Student Council is elected by the General Assembly,

h) Student Council: The governing body of the Student Council,

i) Student Council Supervisory Board: The supervisory body of the Student Council,

j) Student Council President: The chairman of the Student Council and the Student Council Executive Committee,

k) National Student Council of Higher Education Institutions: Students of higher education institutions in Turkey, councils of the heads of the student union,

l) National Student Council General Assembly: The council composed of the presidents of student councils of higher education institutions,

m) National Student Council Convention: With the participation of presidents of student councils of higher education institutions, the general assembly meeting of student councils held every December,

n) Council of National Student Councils Council of National Students: In order for the agenda items to be realized in accordance with the principles of this Regulation at the National Student Council Convention, the delegation selected by the National Student Council General Assembly,

o) National Student Council Administrative Board: The governing body of the National Student Council,

p) National Student Council Supervisory Board: The supervisory body of the National Student Council,

q) Head of National Student Council: refers to the chair of the National Student Council and the Executive Board of the National Student Council.

Definitions made in Article 3 of Law No. 2547 are valid for this Regulation unless otherwise stated.

SECOND PART

Student Council

FIRST PART

General provisions

General guidelines for student representatives elections

Article 5 - The election for the appointment of the members of the Student Council and the formation of the organs in a higher education institution shall be held in November of the relevant year within a period and

schedule determined by the rector of the relevant higher education institution (Amended phrase: RG-24/9 / 2010-27709). In this period and in the elections made within the program, if no result can be obtained for any reason in a unit, the representative (Mulga phrase RG-24/9 / 2010-27709) (...) is not elected. Students who are candidates for student representations shall declare their candidacy at least one week before the election date and may run the election campaign until the end of the day before the election date.

Qualifications to be recruited in student representative candidates

Article 6 - Students who will be nominated for student representatives are required to:

- a) Be a registered student of the relevant faculty, college, conservatory, vocational college or institute,
- b) Not to be a member of a political party or their organs,
- c) the fact that they have not committed a criminal offense which requires removal from the higher education institution,
- d) Their record has not been frozen during the election.

Student council election and working guidelines

Article 7 - The senates of the higher education institutions shall determine the directions for their election and studies of their student councils and student representatives by registering not to be contrary to the provisions of this Regulation.

SECOND PART

Student Council Organs

Student council organs

Article 8 - Student Council Organs, "Department / Program / Department of Education / Student Representative"

"Department / Program / Department of Education / Student Representative Board of Students",

"Faculty / High School / Conservatory / Vocational School / Institute Student Representative", "Student Council

General Assembly ", " Student Council Assembly Council ", " Student Council Board of Directors ", " Student

Council of Supervisory Board "and" Student Council President ".

The student council structuring scheme is shown in EK-1.

THIRD PART

Department, Program, Department, Student Representative

Student representative selection

Article 9 - Department / Program / Undergraduate Degree / Student Degree Representative of a higher education institution must have:

- a) Each department in a faculty, college or conservatory,
- b) Each programme at vocational schools,

c) Each department of the institution in the institute,

d) In a faculty, vocational school or concert hall where students are taken in the program / department of the department / department of the department (RG-24/9 / 2010-27709), students of each program / department / only for the most part, for a period of two years.

At least 60% of the students enrolled in the department / program / main subject branch (if they are secondary education students) are elected in the first round elections in order to be able to make the selection in the student representative offices of department / program / participation of at least 50%

It is essential. If the first two rounds can not be selected, there is no requirement to participate in the third round.

A new representative is selected by the same procedure within one month in the related department / program / department / department in order to complete the duration of the departmental / program / student representative's selection qualifications or to leave the assignment before the end of the course for any reason .

Duties of student representative

Article 10 - Department / Program / Majority Department The tasks of the Student Representative are as follows:

a) To carry out Student Council studies in the department / program / department /

b) announcing and monitoring their implementation in the unit in which they represent the decisions taken by the Student Council bodies,

c) To attend the meetings of the Faculty / Program / Faculty / Department of Student Representatives of the faculties, colleges, conservatories, vocational schools or institutes and to represent the students of their departments / programs /branches in these meetings,

d) To determine the student problems in the department / program / department / main school they represent and to communicate them to the related administrative bodies of the Student Council and the higher education institution,

e) To represent the students of their department / program / department / student in student activities,

f) To develop communication between the administration bodies of the departments represented by the department / program / department / department,

g) Coordinating student activities in the department / program / department / department that they represent,

h) Participating in the academic meetings of the department / program / department / department represented by the students during the discussion of the related subjects.

SECTION FOUR

Department, Program, Department of Anabilim, Student Representative Board

Student representatives board

Article 11 - Department / Program / Division of Student Representatives, a higher education institution:

a) In the faculty, college or conservatory,

b) In the vocational colleges,

c) The main branch of the institute

d) In faculties, higher education institutions or conservatories where students are admitted to the program / department of the department / department of the department, the program consists of the representatives of the students / departments of the program / department and the student councils in the related academic units of the higher education institution.

Department / Program / Undergraduate Degree / Major Degree The Student Representative Council is responsible for the Student Council General Assembly and the Board of Directors.

Department / Program / Master's Degree / Master's Degree Student Representative Board

It meets at least once a month under the presidency of the Faculty / School / Conservatory / Vocational School or Institute Student Representative. The meeting agenda, place and date are announced to student representatives by the chairman at least seven days in advance. In order for the board to be able to convene, the absolute majority of the number of representative members must be included in the decision, and a vote of the majority of the participants in the open vote is required.

In case of equality of votes, the president's vote is determined.

Duties of the student representatives board

Article 12 - Department / Program / Majority Department The duties of the Student Representative Board are as follows:

- a) To conduct studies and follow up the implementation of the decisions of the Student Council in the representation units,
- b) Discussing the problems of the department / program / master / branch and connecting the decisions,
- c) To create and coordinate common student activities in faculties / colleges / conservatories / vocational schools and institutes,
- d) To work to develop communication between the department / program / master / branch students,
- e) To work to improve communication between the academic and management bodies of departments / programs / departments / main branches and related units,
- f) To prepare reports about the studies and to create an archive.

PART FIVE

Faculty, School, Conservatory, Vocational School,

Institute Student Representative

Student representative

Article 13 - Faculty / High School / Conservatory / Vocational School / Institute Student Representative, a higher education institution:

- a) The department in the faculty, college or conservatory,
- b) The program at vocational schools,
- c) The department of the institution / department of the institute,

d) In faculties, colleges or conservatories where students are admitted to the program / department of the department , the student representatives of the program / department /) is elected for two years. Faculties / colleges / conservatories / professions with only one department / program / department / department

In the higher education institutions or institutes, the existing Department / Program / Department of Education or Student Representative of the Department acts as the representative of the faculty / college / conservatory / vocational college or institute in question. (Mülga last sentence: RG-24/9 / 2010-27709) (...).

In case the Faculty / High School / Conservatory / Vocational School / Institute Student Representative lose their qualifications or leave their posts before the end of the period for any reason, the relevant faculty, higher education, conservatory, profession a new representative shall be elected from among themselves in the same procedure within one month at the college or institute. Until the new representative is elected, students from faculties, universities, conservatories, vocational schools or institute student representatives, department / program in the related faculty college, conservatory, vocational college or institute of the higher education institution, members of the Student Representative Board of the Department of Divinity .

Duties of student representative

Article 14 - The duties of the Faculty / High School / Conservatory / Vocational School / Institute Student Representative are as follows:

- a) Student Council in faculties, universities, conservatories, vocational schools or institutes represented to carry out their studies,
- b) Announcing and observing the decisions taken by the Student Council bodies at faculties, colleges, conservatories, vocational schools or institutes they represent,
- c) To determine student problems in faculties, colleges, conservatories, vocational colleges or institutes that they represent and to transmit them to the related administrative bodies of the Student Council and the higher education institution for their solution,
- d) To represent the students of faculties, colleges, conservatories, vocational colleges or institutes in student activities,
- e) Coordinating student activities in faculties, colleges, conservatories, vocational colleges or institutes represented by them,
- f) To preside at the meetings of the representatives of the faculty, school, conservatory, vocational college or institute of the representatives / department / program / department or department of the representatives of the graduate school and to forward the decisions taken in the board to the relevant administrative bodies of the higher education institution,
- g) Participating in the meetings of the board of directors and academic committees of faculties, colleges, conservatories, vocational colleges or institutes represented by the students during the discussion of the relevant subjects.

PART SIX

Student Council General Assembly

Student council general assembly

Article 15 - The General Council of the Student Council consists of the student representatives of the faculties, universities, conservatories, vocational schools and institutes of the higher education institution and is the highest decision body in the Student Council.

In order for the Student Council General Assembly to be convened, the absolute majority of its members must attend the meeting.

The Student Council General Assembly meets regularly at the "Student Council Convention" of the relevant higher education institution, which is affiliated at least once a year and first in November, and constitutes the Student Council bodies.

The Student Council Convention and agenda shall be communicated in writing to the members at least fifteen days prior to the Student Council President. If the number of the meeting quorum specified in this Regulation is not provided on the announcement made, the announcement process is repeated in the same way. Decisions on the formation of bodies in the General Assembly of the Student Council, the absolute majority of the participants, by secret voting; Decisions outside these are taken by the majority of the attendees and by open voting.

The General Assembly of the Student Council may be summoned to the extraordinary meeting by the Board of Directors upon the decision of the Student Council Board of Directors or written application of 1/4 of the members of the General Assembly. In such cases, the General Assembly meeting is held within fifteen days at the latest. The Extraordinary General Assembly meetings and agenda of the Student Council are determined and executed by the Student Council Executive Board.

Duties of the general council of the student council

Article 16 - The functions of the General Assembly of the Student Council are:

- a) To elect the President of the Student Council,
- b) To elect the members of the Student Council Board of Directors,
- c) to elect the members of the Student Council Supervisory Board,
- d) To discuss the problems of the student council and its affiliated higher education institutions,
- e) To determine the term objectives of the Student Council.

CHAPTER SEVEN

Student Council Convention Student Council

Student council

Article 17 - Student Council Convention The Student Council consists of a chairman and two vice presidents, who are members of the General Assembly of the Student Council at the Student Council Convention, which is usually held every November, every year, with members elected by their own majority. Board members can not be candidates for the election of the Student Council Management and Supervisory Board.

Duties of the council of student council

Article 18 - Student Council The functions of the Council are as follows:

- a) To carry out the agenda at the Student Council Convention,
- b) To prepare a separate election compendium for the candidates for the election of the members of the Board of Directors and the Supervisory Board with the Presidency of the Student Council,
- c) To ensure that Student Council presidency and election of members of Board of Directors and Supervisory Board are realized by secret voting,
- d) To announce the voting results of the elections of the Student Council and the election of the members of the Board of Directors and the Supervisory Board and the elections at the Student Council Meeting. Close the congress with the speech of the President of the newly elected Student Council, prepare the closing declaration and submit it to the relevant rector.

SECTION EIGHT

Student Council Board

Article 19 - The Student Council Board of Directors has elected that the members of the General Assembly of the Student Council have elected their members for a two-year term with a simple majority of the electorate and (Changeable: RG-24/9 / 2010-27709); chairman, vice-president, general secretary, treasurer, public relations and IT responsible, foreign relations officer, working groups responsible, education supervisor and health, sports and culture responsible for a total of nine students; In the absence of sufficient representatives to form this number in the General Assembly of the Student Council, the chairman, the general secretary, the treasurer, the education supervisor and the health, sports and culture responsible are composed of five students. The Executive Committee of the Student Council is responsible to the General Assembly of the Student Council.

The Executive Committee of the Student Council meets at least once a month under the management of the Chairman of the Student Council. The meeting agenda, place and date of the Board are announced to the members of the Board of Directors by the chairman at least seven days in advance. In order for the Board to convene, the absolute majority of the total number of the members of the board is required to participate, and the majority of the attendees are required to vote. In cases where the Chairman cannot attend the meetings, a vice-chairman, a vice-chairman of the Board of Directors and the chairman of the Board of Directors may vote and vote. In case of equality of votes, the chairman's vote and the votes of the vice chairman or the member of the Board of Directors shall be determinant in the meetings without the chairman.

Duties of the student council administration board

Article 20 - The duties of the Student Council Board of Directors are:

- a) To ensure that the decisions of the General Assembly of the Student Council are implemented,
- b) To determine the problems of the students in the higher education institution and to transmit their views and ideas to the relevant governing bodies of the higher education institution,
- c) To cooperate with non-governmental organizations to develop social awareness projects and to encourage student participation in these institutions in higher education institutions,
- d) To carry out studies for student participation in national and international "Education and Youth Programmes"
- e) To develop relationships with national and international student unions and organizations,
- f) Working groups in food, transportation, housing, cafeteria, club, scholarship, education, arts, culture and sports areas and to ensure their functioning,
- g) Informing the members of the Student Council General Assembly about their work,
- h) To announce and monitor the decisions of the National Student Council in the higher education institution to which it is attached,
- i) To prepare the reports of the works carried out and to create an archive.

NINTH PART

Student Council Supervisory Board

Student council supervisory board

Article 21 - The Supervisory Board of the Student Council, the General Council of the Student Council,

who will be continuing for two years at the end of his / her education and at least (different phrase: RG-24/9 / 2010-27709)

If there is not enough member of the Board of Directors among the members of the Student Council, on the same terms, the members of the General Assembly shall be elected for a period of one year, by absolute majority of the electors.

The Student Council Supervisory Board consists of a president and two members.

Duties of the student council supervisory board

Article 22 - The duties of the Student Council Supervisory Board are:

a) To check whether the Administrative Board of the Student Council works according to the provisions of this Regulation, the guidelines to be prepared by the relevant higher education institution and the decisions of the General Council of the Student Council,

b) The rector of the relevant higher education institution and the student council general

Inform the board.

SECTION TEN

Student Council President

Article 23 - (Amended first paragraph: RG-24/9 / 2010-27709) Student Council President, Student Council General

Shall be elected by the Board from among the members of the Board, for the absolute majority of the electorates and for a period of two years.

A new president shall be elected within one month by the same procedure to complete the term of office if the President of the Council loses his qualifications for the election or if he leaves his post before the end of the term for any reason. Until the new president is elected, a member of the Student Council shall be elected from among the members of the Student Council Board of Directors.

Duties of the student council president

Article 24 - The duties of the President of the Student Council are:

a) To represent the students of their higher education institution in national and international student activities,

b) To determine the agenda of the Student Council Board of Directors meetings and preside over this meeting,

c) Ensuring the announcement of the decisions taken by the Student Council Board of Directors and monitoring its implementation,

d) Presenting the annual activity report at the end of the term of the next Student Council Conference,

e) Participating in the senate and board meetings of the relevant higher education institution during the discussion of the issues related to the students. In cases where the chairman can not attend, a vice-chairperson or a member of the board of directors meeting to be appointed by the chairman attends the meeting.

THIRD PART

National Student Council

FIRST PART

National Student Council Organs

National student council organs

Article 25 - Organs of the National Student Council; "National Student Council General Assembly", "National Student Council Assembly Council", "National Student Council Board", "National Student Council Supervisory Board" and "National Student Council President" consists of.

The structuring scheme of the National Student Council is shown in EK-2.

SECOND PART

National Student Council General Assembly

National student council general assembly

Article 26 - National Student Council General Assembly, students of higher education institutions in Turkey

It consists of the heads of councils and is the highest decision-making body in the National Student Council.

In order to convene the General Assembly of the National Student Council, must participate.

The General Assembly of the National Student Council, at least once a year, and the first one in December

"National Student Council"

The Congress convenes with its name as the usual and forms the bodies of the National Student Council.

National Student Council Congress and agenda, President of National Student Council whose term of office expires

to be announced to the members at least fifteen days in advance by a higher education institution

is notified to the Rector's Office as registered and registered. Upon the announcement, the meeting stated in this Regulation

the announcement process is repeated in the same way.

At the General Assembly of the National Student Council, the decisions of the bodies are

the majority, secret voting and open counting;

and open voting.

The General Assembly of the National Student Council, the decision of the Executive Committee of the National Student Council or the general assembly

As a result of the written application of 1/4 of the members to the Board of Directors, the Board of Directors mentioned above

the same procedure can be called to an extraordinary meeting. In this case, the General Assembly meeting of the National Student Council

performed within thirty days. The extraordinary meetings of the National Student Council and

The Board of Directors of the National Student Council determines and executes its agenda. Article 27 - The tasks of the General Assembly of the National Student Council are:

- a) To elect the President of the National Student Council,
- b) To elect the members of the National Student Council Board of Directors,
- c) To elect the members of the National Student Council Supervisory Board,
- d) To discuss and challenge the problems of the National Student Council,
- e) To discuss the problems brought by the student councils to the National Student Council General Assembly and to propose solutions,
- f) To determine the term objectives of the National Student Council.

THIRD PART

National Student Council Convention Council

National student council congress council

Article 28 - National Student Council Convention The National Council of Student Council convenes every year at the National Student Council Convention, which is normally held in December every year. Members of the National Student Council General Assembly elect from among its members a chairman and two vice president. Members of the National Student Council Board of Elections can not be candidates for the election of the National Student Council Management and Supervisory Board.

Duties of the council of national student council

Article 29 - National Student Council The functions of the Council are as follows:

- a) To carry out the agenda at the National Student Council Convention,
- b) To prepare separate election compulsory for the candidates for the election of the members of the Board of Directors and the Supervisory Board with the presidency of the National Student Council,
- c) To ensure that the elections of the members of the Board of Directors and the Supervisory Board are carried out by secret ballot and open counting under the chairmanship of the National Student Council,
- d) To announce the voting results of the elections of the elections of the Board of Directors and the Supervisory Board and the elections at the National Student Council Convention, chaired by the National Student Council. The newly elected National Assembly

To close with the speech of the President of the Student Council and to present the closing declaration to the Presidency of the Council of Higher Education.

SECTION FOUR

National Student Council Board of Directors

National student council board

Article 30 - The Board of the National Student Council shall elect the members of the General Assembly of the National Student Council for a period of two years from among themselves, by absolute majority of the elected participants and (Amended expression: RG-24/9 / 2010-27709); consists of a total of nine members: president, vice president, general secretary, treasurer, public relations and information chief, external relations chief, working group chief, education chief, and health, sports and culture chief. The National Student Council Executive Board is responsible for the National Student Council General Assembly.

The National Student Council Board of Directors is administered by the Chairman of the Board of Directors,

Council shall convene at least four times a year in the month following the Convention. The meeting agenda, place and date of the meeting shall be announced to the members of the Board of Directors by the chairman at least fifteen days in advance.

In order for the board to be able to convene, the absolute majority of the number of members of the board must be involved and the votes of the absolute majority of those who participate in the open vote will be required. In cases where the President is unable to attend the meeting, the vice-chairman shall be appointed by the Chairman in the absence of the vice-president.

The board member can carry out this duty and vote. So, in case of equality, the president's vote determines the vote of the vice-chairman or the member of the Board of Directors who is in charge of such a meeting.

Duties of the board of the national student council

Article 31 - The duties of the Executive Board of the National Student Council are:

- a) To ensure the implementation of decisions taken by the General Assembly of the National Student Council,
- b) To improve communication between Student Councils,
- c) To follow the decisions taken by the Higher Education Council and the Universities Council about the students and to announce these decisions to student councils,
- d) Informing the Council of Higher Education and the National Student Council about the studies,
- e) To establish working groups based on national and international project formation,
- f) students in higher education institutions in Turkey or represented at national and international level to ensure,
- g) To cooperate with international student councils and to hold joint events,
- h) Collaborating with non-governmental organizations, national and international social awareness projects develop and disseminate these among higher education institutions,
- i) To prepare the reports of the works carried out and to create an archive.

PART FIVE

National Student Council Supervisory Board

National student council supervisory board

Article 32 - The Supervisory Board of the National Student Council shall be elected by the National Student Council General Assembly from among the members of the National Student Council Board of Directors, whose term of office is to be completed and whose student status is to be at least two (amended: RG-24/9 / 2010-27709) , if not enough members of the Board of Directors are elected from among the

members of the General Assembly on the same terms, and is selected for a year. The National Student Council Supervisory Board consists of a president and two members.

Duties of the supervisory board of the national student council

Article 33 - The duties of the National Student Council Supervisory Board are:

- a) To check whether the Executive Board of the National Student Council works in accordance with the provisions of this Regulation and decisions of the National Student Council General Assembly,
- b) To inform the Council of Higher Education and the National Student Council of the General Assembly about the work they have done.

PART SIX

National Student Council President

President of the National Student Council

Article 34 - The Chairman of the National Student Council shall be elected by the General Assembly of the National Student Council from among the members of the board of directors for a period of two years, with the absolute majority of the elected participants and only for the time being. A president can serve two terms at most.

The President of the National Student Council and the Chairman of the Board of Directors of the National Student Council to be elected among them by the Executive Board of the National Student Council to complete the term of office of the Chairperson of the National Student Council for any loss of qualifications or for any reason.

The duties of the president of the national student council

Article 35 - The duties of the President of the National Student Council are:

- a) To determine the agenda of the meetings of the National Student Council Board of Directors and to chair this meeting,
- b) To coordinate the work of the National Student Council Board of Directors,
- c) ensuring the announcement of the decisions taken by the National Student Council Board of Directors and monitoring its implementation,
- d) To represent the National Student Council in national and international student activities,
- e) Presenting one year's activity report at the end of the term of office at the next National Student Council Convention,
- f) Participating in the meetings of the General Assembly of Higher Education on topics related to the students upon the invitation of the President of the Council of Higher Education.

FOURTH PART

Miscellaneous and Final Provisions

Meeting expenses of students who work in student councils

Article 36 - The President and other student representatives working in the National Student Council and Student Councils bodies shall, in line with the principles of this Regulation, as far as budget possibilities are concerned, they are assigned by the higher education institution they are affiliated with.

Participation fees are paid from the "Higher Education Institution Student Social Services Budget".

Coordination and execution of student councils' work

Article 37 - The National Student Council works with the Higher Education Council and student councils to coordinate their work with the relevant higher education institutions and, where necessary, with the approval of the relevant boards and institutions. Constitution and other applicable legislation.

Duration of the duties of student representatives and organs

Article 38 - The duration of the representations and functions of the National Student Council and all the organs of the Student Councils (Amended phrase: RG-24/9 / 2010-27709) is two years.

Termination of the student representative office Article 39 - The student who has been suspended from the higher education institution for graduation or any other reason

According to the Disciplinary Regulations of Higher Education Institutions published in the Official Gazette dated 13/1/1985 and numbered 18634, the representations of the National Student Council and the Student Councils, which are subject to suspension or removal, are terminated by the student representation, membership and all related duties.

Room for student councils, equipment and equipment Article 40 - In order to perform the duties contained in this Regulation, the Student Council shall be assigned a room which is deemed suitable within the institution by the relevant higher education institution with necessary tools and equipment provided.

End of the membership of the National Student Council

Article 41 - The termination of the Student Council Presidency also ends the membership of the National Student Council of the student.

Provisional Article 1 - The elections of student councils of higher education institutions shall be held in the first November following the date on which this Regulation enters into force, and the National Student Councils congress in the first December. At which higher education institution and at which date the National Student Councils Convention will be held

It is determined by the President of the Council of Higher Education upon the recommendation of the Rectors Committee.

Provisional Article 2 - (Annex: RG-24/9 / 2010-27709)

The chairmen of student councils, institutes, faculties, colleges and conservatories student representatives and higher education institutions, the president of the national student council, members of the board of directors of the higher education institutions selected for these duties before 31/1/2010,

The student council to be held in the institution during the 2011-2012 academic year may remain at the beginning of these duties until the election calendar is announced. However, the total duration of the task can not exceed two years. If any of the representative duties referred to above are vacated, the second paragraph of Article 13 of this Regulations provisions are reserved.

Force

Article 42 - This Regulation shall enter into force on the date of its publication.

Executive

Article 43 - The provisions of this Regulation shall be executed by the President of the Council of Higher Education.
