INSTRUCTIONS ON SUPPORTING RESEARCH
FIRST PART

Purpose, Scope, Basis and Definitions

Purpose

ARTICLE 1- (1) The purpose of this Directive is to determine the procedures and principles for supporting the excavations and surveys to be carried out in relation to cultural and natural assets by the teaching staff in the units affiliated with Nevşehir Hacı Bektaş Veli University.

Scope

ARTICLE 2- (1) This directive covers the procedures and principles for supporting the excavations and surface researches to be carried out in relation to the cultural and natural assets of the academic staff working in the academic units of Nevşehir Hacı Bektaş Veli University.

Basis

ARTICLE 3- (1) This Directive covers the Law on Conservation of Cultural and Natural Assets No. 2863 published in the Official Gazette No. 18113 dated 23.07.1983, Research, Drilling and Excavations Regarding Cultural and Natural Assets dated 10.08.1984 and numbered 18485. It has been prepared based on the provisions of the Regulation.

Definitions

ARTICLE 4- (1) In this Directive following expressions are used:

- a) Ministry: The Ministry of Culture and Tourism,
- b) Head of Department: Heads of relevant departments within Nevşehir Hacı Bektaş Veli University,
- c) Dean: Deans of faculties within Nevşehir Hacı Bektaş Veli University,
- d) Support: In-kind/cash aids to be provided by the University for accommodation, food, transportation, purchase of movable property, excavation and excavation house expenses to be provided for excavations and surface surveys carried out by scientists affiliated to the University within the framework of the law,
- d) General Directorate: General Directorate of Cultural Heritage and Museums,
- e) Permit Certificate: The document issued by the General Directorate for surface surveys and valid during the year,
- f) Law: The Law on the Protection of Cultural and Natural Assets dated 23.07.1983 and numbered 2863,
- g) Excavation: scientific studies carried out in natural, historical and archaeological areas under soil and water using scientific methods to reveal movable and immovable cultural and natural assets,
- ğ) Head of Excavation/Surface Survey: The scientist responsible for the scientific, administrative and financial operation of the excavation and surface survey and for the elimination of the problems that arise,
- h) Instructor: Faculty members with a doctorate degree who teach in the units of Nevşehir Hacı Bektaş Veli University,

- i) Rector: Rector of Nevşehir Hacı Bektaş Veli University;
- i) License: The document issued by the General Directorate regarding the excavation deemed appropriate by the President/Council of Ministers Decision and valid throughout the year,
- j) Senate: Senate of Nevşehir Hacı Bektaş Veli University,
- k) University: Nevşehir Hacı Bektaş Veli University,

SECOND PART

General Terms and Support Applications

ARTICLE 5- (1) Scientists who want to apply for support to the university must comply with the following:

- (2) The academic staff who will apply for support for the excavation must have the Presidential decision or the permission of the Ministry for the relevant excavation area.
- (3) Instructors who will apply for support for surface research must have a permit.
- (4) Support applications are submitted in writing by the heads of excavation/surface research to be forwarded to the relevant department heads to the dean's office and the rector's office.
- (5) A license and permit shall be attached to support applications.
- (6) Support applications are submitted before the excavation/research season.

THIRD PART

Miscellaneous and Final Provisions

Force

ARTICLE 6- (1) This Directive enters into force as of the date of its adoption by the Senate.

Executive

ARTICLE 7- (1) The provisions of this Directive are executed by the Rector.
