

NEVŞEHİR HACI BEKTAŞ VELİ UNIVERSITY
PRACTICE/IMPLEMENTATION PRINCIPLES of SCIENTIFIC AND CULTURAL
ACTIVITIES COURSE

- The events to be held within the university will be automatically registered from the kiosks, and the students are required to have their cards read before the event starts and ends. Event participation not exceeding 30 minutes will not be valid.
- Activities to be executed in "Scientific and Cultural Activities" are determined by the "Scientific and Cultural Activity Detection Commission" in accordance with the Nevşehir Hacı Bektaş Veli University Scientific and Cultural Activities Class Directive and published in the "Events" section on the homepage of our University.
- Provided that the times do not overlap, a maximum of 2 events per day are taken as the basis.
- Each event participation is evaluated as a maximum of 2 hours.
- Entries with only entry or exit records will not be considered.
- The entrance of the library points will be made by the library counter staff.
- Entrance tickets purchased from different places will be valid for museum tours. Each museum tour will be considered as 1 hour.
- Each Cinema will be considered as 1 hour.
- Students who do not complete the compulsory activities; If they have participated in activities for 6 hours or more, FD grade is given, if they have participated for less than 6 hours, FF grade is given.
- Participation in the activities within the time specified for the courses in the academic calendar.
- There are no midterm, final and make-up exams for this course. Exams for students who have completed their maximum duration with a single course exam are applied as homework or projects.
- While entering the grade, the total hours specified in the information system at the address Sistem.nevsehir.edu.tr are entered without considering the decimal parts. Among the students who do not complete their compulsory activities, 6 hours are entered for those who participate in activities for 6 hours or more, and the number of hours they attend for those who participate less.
- Within the scope of the 12th Article of the Framework Regulation for Practical Education in Higher Education, the activity restrictions are applied twice for the students who receive education according to the vocational education model in the enterprise for the period of their professional practice in the enterprise.

Activity Limitations for Scientific and Cultural Activity Course

Museum = Minimum 1, maximum 3 participation (Mandatory)

Library = Minimum 1, maximum 3 participation (Mandatory)

Cinema = Maximum 2 entries

Theater = Maximum 2 entries

Sports Competitions = Maximum 2 entries

Exhibition = Maximum 2 entries

Success evaluation is based on total time (total hours and minutes spent in Events).

- FF between 00:00 – 05:59
- Between 06:00 – 06:59 FD
- DD between 07:00 – 07:59
- DC between 08:00 – 08:59
- CC between 09:00 – 09:59
- CB from 10:00 to 10:59
- BB between 11:00 – 11:59
- 12:00 – 12:59 BA
- 13:00 and after are considered as AA.
