Amending Regulation of Regulation of Turkish and Foreign Language Teaching **Application and Research Center**

ARTICLE 1 - The name of Nevşehir University Turkish and Foreign Language Teaching Application and Research Center Regulation, published in the Official Gazette dated 19/10/2013 and numbered 28796, has been changed to "Nevşehir Hacı Bektaş Veli University Turkish and Foreign Language Teaching Application and Research Center Regulation"

ARTICLE 2 - Article 1 of the same Regulation has been amended as follows.

"ARTICLE 1 - (1) The purpose of this Regulation is to regulate the principles and procedures regarding the objectives, fields of activity, administrative bodies, duties and working methods of the administrative bodies of Nevşehir Hacı Bektaş Veli University Turkish and Foreign Language Teaching Application and Research Center"

ARTICLE 3 - The phrase "Nevşehir University" in article 2 of the same Regulation has been changed to "Nevsehir Hacı Bektaş Veli University".

ARTICLE 4 - Article 4 of the same Regulation has been amended as follows.

- "ARTICLE 4 (1) In this Regulation following expressions are used:
- a) Center (NEÜTÖMER): Nevşehir Hacı Bektaş Veli University Turkish and Foreign Language Teaching Application and Research Center,
 - b) Director: Director of the Center,

- c) Rector: Rector of Nevsehir Hacı Bektaş Veli University,
- ç) University: Nevşehir Hacı Bektaş Veli University,
- d) Board of Directors: The Board of Directors of the Center"

ARTICLE 5 - Items (g), (h) and (m) of the first paragraph of Article 5 of the same Regulation have been changed as follows.

- "g) teaching Turkish to foreign students studying in associate degree, undergraduate, graduate programs of the university, face to face and / or by distance education."
- "h) to conduct face-to-face and/or distance learning Turkish level determination exams for foreign nationals and to issue certificates accordingly."
- "m) to organize face-to-face and / or distance education programs intended to the third and fourth grade students of the Departments of Turcology abroad and the students of Turkish universities studying at Turkish Teaching, Turkish Language and Literature, Turkish Language and Literature Teaching, Modern Turkish Languages and Literatures, Turkish Folklore, Linguistics and Foreign Languages Departments

ARTICLE 6 - The phrase "Nevşehir University" in article 16 of the same Regulation has been changed to "Nevsehir Hacı Bektaş Veli University".

ARTICLE 7 - This Regulation enters into force on the date of its publication.

ARTICLE 8 - The provisions of this Regulation are executed by the Rector of Nevşehir Hacı Bektas Veli University.
